1. No food, drink or chewing gum on or around the photo booth. This will avoid a choking risk and keep the unit clean. (Please note if the photo booth is collected in a dirty condition then the person hiring it will incur a cleaning charge)
2. No face paints, party poppers, colored streamers or silly string to be used either on or near the Inflatable. (Please note these products will cause damage to the Inflatable that cannot be repaired)
3. NO smoking on or around the photo booth.
4. NO barbeques around the photo booth.
5. A responsible Adult must supervise the photo booth at all times.
6. Always insure that the photo booth is not overcrowded, and limit numbers according to the age and size of children and/or adult using it. Try to avoid large and small children from using it at the same time.
7. Ensure Children are not pushing, colliding, fighting or behaving in a manner likely to injure or cause distress to others.
8. No pets, toys or sharp instruments on the inflatable at anytime...
9. In the event that the photo booth stops working, please ensure all users get off the photo booth immediately and calmly. Check your breakers) and make sure the photo booth or something has not caused a disconnection. In the event that it overheats, or loses power, switch the main power switch on and off after assuring a solid connections, If it does not, inform us immediately at 785-580-7605.
- 10. THE MOST IMPORTANT RULE: DO NOT let children control the photo booth without Adult supervision. Adult supervision is necessary to enforce these rules for safe operation of the photo booth.**

7. If the photo booth equipment is lost, stolen, or damaged beyond repair, the renter agrees to pay \$1500.00.

8. Customer agrees to ensure that all users (and users' guardians) of the rental equipment sign liability waivers.
